### Conditions of Participation

[1] I hereby confirm that the short film I have submitted is truly an unknown film in the sense that this film has never been shown to a sizeable audience before.

[2] It is my desire that my submitted short film will be shown to a public audience at the U.F.O. Short Film Festival in Leipzig. Accordingly, I assert that the persons responsible for the U.F.O. Short Film Festival together with the Leipzig University of Applied Sciences (Hochschule für Technik, Wirtschaft and Kultur Leipzig, short: HTWK) are exempt from any and all outstanding third party claims regarding the submitted film and I hereby authorize the following:

- (1) Permission to show the submitted film at the U.F.O. Short Film Festival that will take place on January 15, 2010 in the „Werk II“ in Leipzig.
- (2) Permission to present the film in a public cinema at a later date. Information about concrete location and date of the presentation will be given to the filmmaker as soon as possible.
- (3) Permission to submit parts of the film, which will not exceed 20 per cent of the whole film length (trailer), without explicit authorization to TV stations, radio stations, press and the internet for promotional purposes.

[3] Furthermore, I proclaim, concerning all of the legitimate rights of the film authorized to the authors, creators, as well as all other participants in the production of this motion picture who have collaborated or whose other efforts were employed in the final product, power of attorney has been transferred and is hereby acknowledged.
